2024 VALUATION RELIEF PROGRAMS INFORMATION

Personal Exemptions: An exemption that reduces the Assessed Limited Property Value (LPV) which is the taxable amount due on one's properties up to \$4,476 for qualified applicants.

Service requirement: Honorable discharge or retirement benefits, excluding Social Security 9. Veteran Exemption: Exemption amount is based on percentage and/or Veterans disability payments, may be of disability requested.

Senior Valuation Protection and Qualifications: A freeze to the Limited Property Value (LPV) (the taxable portion of your property taxes) at the current tax year's value for 3 consecutive years.

- 1. Who is eligible? Seniors 65+
- 2. Application Period: Between January 1 and September 1
- 3. Renewal period: Every 3 years
- 4. **Income limit:** Adjusted Gross Income of \$45,264 for single-owner and \$56,580 for multiple owners during the prior 3 years (income average), **including** Social Security and/or Veterans disability payments, may be requested. (Owner(s) defined as those listed on ownership/deed)
- 5. Property Value Limit: None
- 6. Residency: Primary residence for a minimum of 2 years and associated parcels up to 10 acres
