Arizona Revised Statutes § 542-15203.A. states, "Any person owning a mobile home that is permanently affixed to real property may file an affidavit of affixture with the county recorder of the county in which the real property is located."

INSTRUCTIONS FOR COMPLETING THE AFFIDAVIT OF AFFIXTURE

<u>LEGAL DESCRIPTION:</u> The owner completes the legal description and the county assessor's parcel number for the real property (land) on which the mobile home is or will be permanently located. The information requested may be obtained from the county assessor's office.

<u>PROPERTY TAXATION:</u> This section is completed and signed by the owner of the mobile home. In the event of a sale, this section is completed and signed by the buyer. The information requested may be obtained from the county treasurer's or county assessor's office.

NOTE: IF THE TAXES ON THE MOBILE HOME ARE DELINQUENT, THE MOTOR VEHICLE DIVISON WILL NOT ACCEPT THE MOBILE HOME DOCUMENTS FOR SURRENDER. TAX INFORMATION FOR PRIOR YEARS IS AVAILABLE AT THE COUNTY TREASURER'S OFFICE.

<u>RECEIPT FOR SURRENDERED MOBILE HOME DOCUMENTS:</u> The surrender of the documents is subject to the regulations of the Department of Transportation, Motor Vehicle Division. The receipt is completed by an agent of the Motor Vehicle Division. If the mobile home has not been titled previously the dealer must provide the first price.

<u>RECORDING OF THE AFFIDAVIT:</u> The Affidavit should be submitted to the County Recorder for recording after the Affidavit has been completed and the mobile home documents have been surrendered to and signed off by the Motor Vehicle Division. The name and address of the owner or the other person to whom the recorded document is to be returned should be inserted in the space provided.
